Date: February 15, 2021 To: Board President Woolley and Members of the Board Re: Formal Grievance #2 and Call for Immediate Action

This grievance is submitted in objection to Action Agenda Item C - Seating of Board Member (Ms. Judith Barba) to the Tulsa Public Schools Board of Education at the February 16, 2021, Special Meeting.<sup>1</sup> We submit for the following reasons that proceeding with Item C creates inextricable conflicts for the Board and serves to compromise the District in ways violative of the public trust:

- Tulsa School Board Policy 1102 includes a subsection entitled *Contracts with Board Members or Business in Which Board Members Have an Interest* and explicitly prohibits the District from entering into a contract "with a Board member or any company, individual, business concern, or other entity in which any Board member is directly or indirectly interested, except as otherwise provided by Oklahoma law."<sup>2</sup>
- On June 18, 2020 the Board approved an agreement for contracted services provided by Growing Together to the District in the amount of \$390,000 to provide services for students and teachers.<sup>3</sup>
- Ms. Barba herself is employed by Growing Together, an entity whose work is so closely bound up with that of the School District's that employees of Growing Together are assigned positions as "Site Coordinators" inside of four schools belonging to the sub-district Ms. Barba would represent.<sup>4</sup> Due to the nature of the services provided, Ms. Barba functions as a de facto employee of the District. Due to the extant contract with Growing Together, Ms. Barba's loyalty to the District could be divided.
- Seating Ms. Barba on the Tulsa Public Schools Board of Education brings the Board and therefore the District into violation of <u>70 O.S. 5-124</u>, <u>Contract Requirements and</u> <u>Prohibitions</u> and <u>Tulsa Public Schools Board Policy 1102</u>, <u>Contracts with Board Members or</u> <u>Business in Which Board Members Have an Interest</u>.
- The administration of the Oath of Office by Mr. Eric Wade, Counsel to the District, is objectionable on the grounds that doing so could *create* for his client a violation of its own policies explicitly prohibiting the District from entering into a contract "with a

Board member or any company, individual, business concern, or other entity in which any Board member is directly or indirectly interested...<sup>35</sup>

• Pursuant to Tulsa Public Schools Board of Education Policy 1102, "questions concerning the application of this portion of this policy [Contracts with Board Members or Business in Which Board Members Have an Interest] will be referred to the Board attorney for a written opinion." Mr. Eric Wade, variously the Attorney for the Board and the Attorney for the District<sup>6</sup> has not followed up with a written response to a grievance filed previously against Board Member Jania Wester whose spouse is the Executive Director of Growing Together.

For the reasons listed above, we insist that the Board of Education remove Item C - Seating of Board Member Judith Barba from the Action Agenda of the Special Meeting of the Board of Education. Our intention here shall not to be construed to diminish the work of Ms. Barba nor of Growing Together but instead taken as a demonstration of our insistence that the Board of Education uphold the laws which imbue it with the authority and the responsibility to govern without conflict and as representatives of the people not proxies for individual Board Members' professional interests.
