Date: February 12, 2021 To: Board President Woolley

Re: Formal Grievance Per Board Policy 1102 and Request for Action

Tulsa Public Schools Board Policy 1102 subsection *School Board Member Conflict of Interest* reads "No Board member should use the District affiliation for private or personal advantage." The policy further states, "No Board member should have any outside business interests which might, in fact or appearance, interfere with the individual's loyalty to the District." The idea is to prevent the practice of nepotism, divided loyalty, and using one's office for personal or private gain.

Presently Board of Education Member Jania Wester has personal, professional, and contractual interests in District Business and, through actions taken as a Board Member, derived benefit and advantage for Growing Together, an entity which provides contracted services to students and teachers at school sites in Board Member Wester's district. Additionally, Growing Together is overseen and managed by her spouse, Kirk Wester in violation of 70 O.S. § 5-113 which prohibits "persons who are related within the second degree of consanguinity or affinity to an employee of a school district from serving on the board of education governing the school district while such relative is employed." Clearly, Board Member Jania Wester serves on the Tulsa Public Schools Board of Education in violation of Board Policy 1102 and 70 O.S. § 5-113 (OSCN 2021).

- Board Member 2 Jania Wester did not disclose Growing Together, an entity her spouse, Kirk Wester, manages as its Executive Director on the 2019 Board Member Financial Disclosure filed with the Board Clerk.<sup>3</sup>
- On July 6, 2020 Board Member 2 Jania Wester voted to approve an encumbrance of \$390,000 paid by the District to Growing Together.<sup>4</sup> Meeting minutes record Board Member Wester approving the encumbrance.<sup>5</sup>
- On March 23, 2020 Board Member 2 Jania Wester voted to approve the payment of \$112,000 to Resolute PR, a marketing firm that performed work in concert with Growing Together Executive Leadership to "brand" Tulsa Public Schools in Board Member Wester's District with the Growing Together brand. The work done by Resolute PR benefitted Growing Together.

Therefore, Jania Wester must forfeit her office pursuant to 70 O.S. § 5-113 (D) which states, "Any member of a board of education who violates the provisions of this section shall be subject to the penalties

prescribed by <u>Sections 485</u> and <u>486 of Title 21</u> of the Oklahoma Statutes." For reference, Section 485 of Title 21 states, "Any executive, legislative, ministerial or judicial officer who shall violate any provision of this Article, shall be deemed guilty of a misdemeanor involving official misconduct, and shall be punished by a fine of not less than One Hundred or more than One Thousand Dollars (\$1,000.00), and shall forfeit his office."

Pursuant to Tulsa Public Schools Board of Education Policy 1102, "questions concerning the application of this portion of this policy [Contracts with Board Members or Business in Which Board Members Have an Interest] will be referred to the Board attorney for a written opinion." This is a formal request to trigger the process whereby the Board attorney will respond with a written opinion on this matter detailing the steps for remedying this untenable situation with the removal of Jania Wester from the Tulsa Public Schools Board of Education and outlining steps for the avoidance of this violation in the future.
